

SECTION V - REACTIVITY DATA

STABILITY: STABLE

CONDITIONS TO AVOID

Heat, sparks, or open flames.

INCOMPATIBILITY (MATERIALS TO AVOID)

Strong oxidizing agents.

HAZARDOUS DECOMPOSITION OR BYPRODUCTS

May produce hazardous decomposition products when heated. Fumes may contain : carbon monoxide, carbon dioxide .

HAZARDOUS POLYMERIZATION: WILL NOT OCCUR

SECTION VI - HEALTH HAZARD DATA

INHALATION HEALTH RISKS AND SYMPTOMS OF EXPOSURE

Vapor and spray mist may be harmful if inhaled. Symptoms : headaches, dizziness, confusion.

SKIN AND EYE CONTACT HEALTH RISKS AND SYMPTOMS OF EXPOSURE

In case of skin contact, flush immediately with plenty of water followed by washing with soap and water .In case of eye contact, flush eyes immediately with plenty of water for at least 15 minutes.

SKIN ABSORPTION HEALTH RISKS AND SYMPTOMS OF EXPOSURE

Dryness, itching, cracking, burning, redness, and swelling are conditions associated with excessive skin contact.

INGESTION HEALTH RISKS AND SYMPTOMS OF EXPOSURE

Can cause gastrointestinal irritation, nausea, vomiting, and diarrhea. Aspiration of material into lungs can cause chemical pneumonitis which can be fatal.

HEALTH HAZARDS (ACUTE AND CHRONIC)

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED

Provide maximum ventilation. Only personnel equipped with proper respiratory and skin and eye protection should be permitted in the area. Remove all sources of ignition. Take up spilled material with absorbent material place in container.

WASTE DISPOSAL METHOD

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORING

Do not store above 120F. Store large quantities in buildings designed for storage of NFP class IIIB combustible liquids.

RESPIRATORY PROTECTION

If workplace exposure limits of product or any component is exceeded (see section II), a NIOSH/MSHA approved air supplied respirator is advised in absence of proper environmental control. OSHA regulations also permit other NIOSH/MSHA respirator (negative pressure type) under specified conditions. Controls should be implemented to reduce exposure.

VENTILATION

Use only with adequate ventilation. Provide general dilution or local exhaust ventilation in volume and pattern to keep air contamination concentration below current applicable safety and health standards.

PROTECTIVE GLOVES

Gloves constructed of: Nitrile rubber, neoprene.

EYE PROTECTION

Do not get in eyes. Safety eyewear with splash guards or shields is recommended to prevent contact.

OTHER PROTECTIVE CLOTHING OR EQUIPMENT

When spraying overhead a spray hood or spray sock should be worn.

WORK/HYGIENIC PRACTICES

Remove and wash soiled clothing after use. Wash hand before eating, drinking or smoking.
